**RESOLUTION OF INTENT TO NONRENEW THE CONTRACT OF AN ADMINISTRATOR WITH TWO OR MORE YEARS EMPLOYMENT AS ADMINISTRATOR IN THE DISTRICT**

RESOLUTION

WHEREAS, Kay Stimatze is currently employed as an administrator in Unified School District No. 351, Stafford County, Kansas; and

WHEREAS, after extensive consideration of the matter, the Board of Education of Unified School District No. 351, Stafford County, Kansas, finds that the contract of Kay Stimatze as an administrator should not be renewed for the 2026-2027 school year, and that she should be given notice of the board's intent;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF UNIFIED SCHOOL DISTRICT NO. 351, STAFFORD COUNTY, KANSAS, as follows:

- Section 1. It is the intent of the board of education that the employment contract of Kay Stimatze as an administrator not be renewed for the 2026-2027 school year.
- Section 2. The clerk of the board of education is hereby directed to give Kay Stimatze written notice on or before May 22, 2026, of the board's intention to not renew her contract for the 2026-2027 school year. The notice shall also inform Kay Stimatze that she may file a request for a meeting with the board, to be held in executive session, by filing a written request with the clerk of the board within ten (10) days after her receipt of the notice of the board's intention of nonrenewal. The notice shall inform her that, at the meeting, the board will specify the reason or reasons for the board's intention to not renew the contract, and she will have an opportunity to respond to the board. Neither party will have the right to have counsel present.




